## 2024-25 Technical TSM Measures

As part of the Consumer Standards we are required to report on Tenant Satisfaction Measures every year. ## Performance notes

BS02 – Fire Risk Assessments

As at 31 March 2025 there were 7 homes within two blocks for which the fire risk assessments (FRAs) had expired:

- One block, containing two homes is a Willow Tree Housing Partnership (WTHP) owned block. At the time of publishing, confirmation of completion of the new FRA was awaited.
- The other block, containing five WTHP homes, is owned and managed by a third party.
  At the time of publishing, a new FRA had been booked in for completion and confirmation of the same was awaited.

BS03 – Asbestos Management

As at 31 March 2025 50 homes where asbestos is known or assumed to be present, did not have an asbestos management survey/re-inspection survey recorded. At the time of publishing orders for these surveys had been placed and confirmation of their completion was awaited.
